These low cost services will be provided to Indian River County residents only. Our goal is to control pet overpopulation as well as the health and behavior benefits that come from spaying and neutering a family pet.

When these are complete, please call and leave a message at 772-388-3331 ext 40. We will contact you to schedule an appointment for an eligibility consultation. Bring all paperwork with you as well as monies (cash, credit or debit only) to pay for your pet's surgery.

The above fee will cover a pre-surgical exam; spay/neuter surgery, anesthesia and pre-surgery medications as necessary. Not included are vaccines, blood work, or other post op medications. This fee will not cover additional fees for animals in heat, pregnant, cryptorchid surgery, or a scrotal ablation etc.

Any of these procedures or procedures not related to spay/neuter surgery; may be offered at an additional expense or referred.
